



## CONTRACT

concluded by and between:

- I. Academic basketball camp "Profesor Aleksandar Nikolić", Učitelja Dragutina Prokića Street No.6, 11000 Belgrade, Company Code: 17463730, tax identification No. 102761540, represented by legal representative Dušan Pavićević, hereinafter referred to as **Contractor 1**

And

### Article 1.

The subject of this contract is to regulate the mutual rights and obligations of the contracting parties in regarding the holding of a sports basketball camp in Zlatibor for a shift \_\_\_\_\_ in period \_\_\_\_\_.

### Article 2.

**Contractor 1** is obliged to provide to **Contractor 2** use of sports camp services, which include: accommodation, full board, sports fields for training, work with trainers, equipment, medical supervision 24/7. **Contractor 1** undertakes to provide services conscientiously, in accordance with generally accepted rules of the profession and the usual practice for that type of work.

### Article 3.

**Contractor 2**, as a user of the services specified in Article 2 of this contract, is obliged to pay the total amount of EUR \_\_\_\_\_ in dinars in the name of the fee for the provision of services equivalents at the middle rate of the NBS on the day of payment, in equal monthly instalments or in whole, and at the latest until the beginning of the starting of the shift camp \_\_\_\_\_, that is \_\_\_\_\_.

**Contractor 2** is obliged to respect the organization of the Camp's work, trainings and other activities, to follow the instructions and advice of the organizers of the camp as well as all other persons who participate in the work and implementation of the Camp program.

If the **Contractor 2** does not meet the conditions from paragraph 2 of this article by his own will, his own fault or decides to leave the camp on his own, he has no right to a refund of paid funds.

#### Article 4.

**Contractor 1** reserves the right to terminate the contract without refund of the funds paid if **Contractor 2** does not comply with the rules of conduct and organization of the camp, interferes with the work of the expert staff and other participants at the camp, damages property or interferes proper work and organization. In that case Contractor 2 will be excluded from the camp and will fully indemnify Contractor 1.

#### Article 5.

The contracting parties agree that **Contractor 2** has the right to withdraw from of using the services of Contractor 1 no later than 30 days before the start of use a favor. Then, **Contractor 1** undertakes to return the entire amount to **Contractor 2** by then received funds.

If **Contractor 2** cancels no later than 14 days before the start of using the services, **Contractor 1** undertakes to return 50% of the funds received up to that time, which is fully accepted by **Contractor 2**.

If **Contractor 2** withdraws after the above-mentioned deadlines, it is agreed that **Contractor 1** shall retain the entire amount received up to that point, as a compensation for damages.

#### Article 6.

Provisions of the Law on Contracts and Torts and other relevant regulations of Republic of Serbia shall govern all issues not regulated herein.

#### Article 7.

The Contracting Parties shall resolve any disputes arising out of or in relation to this agreement amicably, failing which jurisdiction shall be ceded to the competent court with territorial jurisdiction.

#### Article 8.

This Agreement is made in 2 (two) identical copies, from which each Party receives 1 (one) copy.
